



The FBI's Uniform Crime Reporting (UCR) Program collects crime data from law enforcement agencies throughout the country via the National Incident-Based Reporting System (NIBRS). In 2024, there were 70,523 incidents of teen relationship violence where either the victim or offender was 13 to 19 years old. The following graphics show teen victims and offenders; the victim/offender relationships of boyfriend/girlfriend, ex-relationship, spouse, and ex-spouse; offenses; and injuries. Offenses analyzed are murder and nonnegligent manslaughter, negligent manslaughter, rape, sodomy sexual assault with an object, criminal sexual contact, robbery, aggravated assault,¹ simple assault,² intimidation, statutory rape, commercial sex acts, and involuntary servitude.

Teen relationship violence data is based on the NIBRS definition of Domestic and Family Violence—"The use, attempted use, or threatened use of physical force or a weapon; or the use of coercion or intimidation; ...a person who is or has been in a social relationship of a romantic or intimate nature with the victim."³

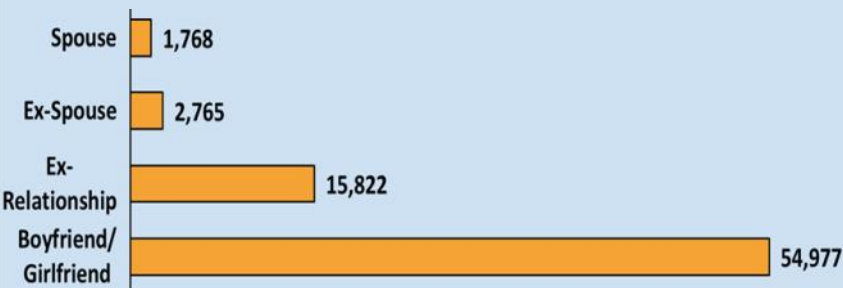
Victims and Offenders

Age and Gender

- 63.0% of victims were 17 to 19 years old.
- 42.1% of offenders were 18 to 19 years old.
- 79.2% of victims were female.

Relationships

73.0% of relationships were reported as boyfriend/girlfriend.



Offenses

- Simple assault was the most reported offense for victims 15 years old and older.
- Rape was the most reported offense for victims 14 years old and under.

Injuries

- Injuries were reported for 47.8% of reported victims.
- Apparent minor injury* was the most reported at 90.0%.

Weapons

The weapon most reported for teen dating violence incidents was Personal Weapons (hands, fist, feet, arms, teeth, etc.) at 62.4%.

¹ The NIBRS definition of aggravated assault is "An unlawful attack by one person upon another wherein the offender uses a dangerous weapon or displays it in a threatening manner or the victim suffers obvious severe or aggravated bodily injury, or where there was a risk for serious injury/intent to seriously injure."

² The NIBRS definition of simple assault is "An unlawful physical attack by one person upon another where neither the offender displays a dangerous weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness."
